ZBA 16-003: A Public Hearing on a Special Use Permit application for the operation of a Recreation Vehicles Sales business in an IL Light Industrial Zoning District by the owner of the property at 11951 Main Street, PIN 04-28-326-015. David Jack: Applicant. David Jack was present and sworn in to represent LP Motorsport. This was put back on the agenda from February 17, 2016 because the public hearing was not published. Mr. Jack stated nothing had changed. Public Hearing opened at 5:32 PM. Mr. Jack stated they have outgrown their present facility and are moving to Roscoe. Doyle General Sign Contractors: Applicant. John Street, Doyle Signs, Inc. was present and already sworn in to represent Fas Mart/Fas Fuel. He will be changing out the Road Ranger sign for Fas Mart/Fas Fuel. This site is nearly identical to the N 2<sup>nd</sup> Street station, except it has no diesel canopy. See Application No. ZBA 16-017 (Attachment 3, 4 pages). Zoning Administrator Sanders stated the existing sign does exceed the total allowable sq. ft., but they are re-facing an existing pylon sign.
