VILLAGE BOARD MEETING MINUTES
Tuesday January 5, 2016**

1. CALL TO ORDER

President Krienke called the Village Board meeting to order at 6:30 PM on Tuesday, January 5, 2016.

President Krienke called for Roll Call: Present: Trustees Baxter, Gustafson, Mallicoat, Petty, Swanson. Absent: Trustee Muradian

4. APPROVAL OF MINUTES

- **Approval December 15, 2015 Village Board minutes.** President Krienke entertained a motion to approve the minutes. Trustee Petty made a motion to approve; seconded by Trustee Swanson. Roll Call Vote: Trustees Baxter, Gustafson, Mallicoat, Petty, Swanson –Yes. Trustee Muradian – Absent. Motion approved 5-0-1.

5. PUBLIC COMMENT (Limited to 3 minutes per speaker)

- Steve Woodman corner of 4th Street and Fry Drive handed out pictures of culvert on Fry Drive (**Attachment 1, 3 pages**). He has had several conversations with Public Works Supervisor and is unhappy with the outcome.

6. PRESIDENT’S REPORT – Dave Krienke

- President Krienke stated he will be putting together a meeting sometime at the end of January or first of February at the school with residents to discuss the garbage issues and new police department.

8. TREASURER’S REPORT – Mark Olson

- **Cash Report:** Gail Beach gave the Treasurer’s report.
- **Approval of Bills.** Treasurer Beach stated the total expenditures submitted for approval on January 5, 2016 are \$279,113.31 from the General Fund. MFT expenditures were \$1,295.00. President Krienke entertained a motion to pay the bills. Trustee Baxter made a motion to pay the bills; seconded by Trustee Swanson. Roll Call Vote: Trustees Baxter, Gustafson, Mallicoat, Petty, Swanson - Yes. Trustee Muradian – Absent. Motion approved 5-0-1.

9. COMMITTEE OF THE WHOLE

- **Approval authorizing Rock River Energy Services Company to bid electric aggregation.** President Krienke entertained a motion to approve. Trustee Petty made the motion; seconded by Trustee Swanson. No discussion. Roll Call Vote: Trustees Baxter, Gustafson, Mallicoat, Petty, Swanson - Yes. Trustee Muradian – Absent. Motion approved 5-0-1.
- **Approval of Resolution 2015-R59, a Resolution for the installation of a street light at the intersection of Swanson Road and Leicester.** President Krienke entertained a motion to approve. Trustee Petty made the motion; seconded by Trustee Swanson. Resolution 2015-R59 should be 2016-R01; however, it was decided to leave as is. Administrator DeGrave stated the cost for the light should be under \$20.00 per month. Mr. DeGrave is also exploring other locations for street lights. Roll Call Vote: Trustees Baxter, Gustafson, Mallicoat, Petty, Swanson - Yes. Trustee Muradian – Absent. Motion approved 5-0-1.
- **Approval of Resolution 2015-R60, a Resolution approving revisions to the job description for the Public Works Superintendent.** President Krienke entertained a motion to approve. Trustee Petty made the motion; seconded by Trustee Swanson. Trustee Gustafson proposed some minor changes to the job description. This will remain as Resolution 2015-60 (**NOTE to Trustees: This will become 2016-R01**). She then made a motion to lay over for two weeks so changes can be made; seconded by Trustee Baxter. Voice Call Vote: All ayes present; no nays heard. Motion approved 5-0-1.

Trustee Petty asked if the Rock River Disposal bill was paid. This will be paid.
