President Krienke entertained a motion to approve. Trustee Mallicoat made the motion; seconded by Trustee Baxter. Roll Call Vote: Trustees Baxter, Gustafson, Mallicoat, Muradian, Swanson Yes. Trustee Petty Absent. Motion approved 5-0-1.
- **9.3** Approval of Resolution 2016-R20, a Resolution approving policy for Fund Balance and Reserves (Final Approval). President Krienke entertained a motion to approve. Trustee Gustafson made a motion to amend the Resolution to read "a Resolution approving policy for Fund Balance to six months at 50% of the Reserves; seconded by Trustee Muradian. Trustee Gustafson stated 49% of Government has balances at the six month amount and the remainder of Municipalities has 5-15% of their general revenue with a minimum of three months reserves; so 60% is the norm. Fund Balance and Reserve Policy attached (Attachment 6, 2 pages). President Krienke stated for the record with the current condition of the State of Illinois, he would like to see the Village at eight months because the State has ran six months behind in paying their bills. The additional two months would cover having to borrow for any unforeseen problems.

Trustee Swanson – No. Trustee Petty – Absent. Original motion approved as amended 4-1-1.

Trustee Muradian made the motion; seconded by Trustee Swanson. Voice Call Vote: All ayes present, no nays heard. Motion approved to lay over 5-0-1.
