1. CALL TO ORDER

- **3.1. Approval of February 16, 2016 Liquor Commission minutes.** President Krienke entertained a motion to approve the minutes. Trustee Muradian made the motion; seconded by Trustee Petty. Roll Call Vote: President Krienke, Trustees Mallicoat, Muradian, Petty, Swanson Yes. Trustee Baxter Abstain. Trustee Gustafson Absent. Motion approved 5-0-2.
- 3.2. Discussion and recommendations in regard to Penny, Inc. d/b/a Sarandy's Food & Liquor hearing proceedings (2014-LC-01). Attorney Kurlinkus stated the Board had a Finding of Facts and agreed order for violation of employee registration and server role from 2014. The business owners were present and had copies of findings. Sarandy's was in violation of sections 114.62a, 114.62i and 114.03a. They agreed to a \$5,000.00 fine and be closed for 17 full business days with credit for the 16 days they had already been closed (August 12 August 28, 2014 the 17th day would be served in May 2016). Trustee Muradian made a motion to accept the stipulations and send to the Board for approval; seconded by Trustee Petty. Roll Call Vote: President Krienke, Trustees Baxter, Mallicoat, Muradian, Petty, Swanson Yes. Trustee Gustafson Absent. Motion approved 6-0-1. Discussion was held on whether or not Sarandy's could pay \$1,000.00 a month for the next five months. The Board did not agree and Sarandy's would have to pay the \$5,000.00 by tomorrow or they would be in violation.

• Trustee Muradian asked if Doty's had gotten their business straightened out. President Krienke stated the owner of the property was difficult to work with and will not approve the design for Doty's.
