#### MINUTES OF June 3, 2016

A special scheduled meeting of the Village of Roscoe Board of Fire and Police Commissioners was held in the main conference room of the Roscoe Village Hall on June 3, 2016. Chairman Garcia called the meeting to order at 5:36 p.m.

#### **Roll Call**

The Roll was called. Chairman Garcia, Commissioner Nytko, and Commissioner Seibert were present. Also in attendance were Attorney Charles Kostantacos and Ms. Kylie Loewecke.

#### Minutes

The Commissioners reviewed the Minutes of the May 18<sup>th</sup>, 2016 meeting. No additions or corrections were made. On motion by Mr. Seibert and second by Mr. Nytko, the minutes were approved as written by unanimous roll call vote; 3-0-0.

Attorney Kostantacos announced he was still waiting on IO Solutions to give him a time frame for promotional testing. Nothing had been received by him as of yet, and he indicated he would again persist in contacting IO Solutions for a timeline and any promotional testing documents for review.

The board studied and discussed each of the preference points claims submitted by the entry-level candidates, since the deadline to turn in the claims passed on June 2<sup>nd</sup>, 2016. No claims submitted had been denied. Ms. Loewecke, utilizing the approved preference points as dictated in 5/10-2.1-8 and 5/10-2.1-9 of the Act of General Assembly entitled "Division Board of Fire and Police Commissioners" of Chapter 65 of the Illinois Compiled Statues, computed a finalized eligibility list. Upon hearing the updated list, Mr. Seibert moved to adopt the entry-level police officer final eligibility list as prepared by the Secretary at the direction of the Village of Roscoe Fire and Police Commission. Mr. Nytko seconded the motion and by unanimous roll call vote the board moved to adopt the final eligibility list.

### <u>Bills</u>

An invoice from IO Solutions for cost of the most recent entry-level testing they had conducted in the amount of \$1,100.00 was brought forth. Payment was approved on motion by Mr. Nytko, second by Mr. Seibert, and unanimous roll call vote.

A bill from the Law Offices of Charles P. Kostantacos for the month of May 2016, in the amount of \$1,393.75, was presented for review. Payment was approved on motion by Mr. Nytko, second by Mr. Seibert, and unanimous roll call vote.
