MINUTES OF July 20, 2016

Minutes

Old Business

The board revisited the topic of promotional testing by IO Solutions. Attorney Chuck Kostantacos reported IO Solutions had trouble working with the dates provided by the board previously, specifically October 22nd, 2016 or October 29th, 2016.
