**MUNICIPAL OFFICERS ELECTORAL BOARD MINUTES

**1) CALL TO ORDER**

Chairman Krienke called the Village of Roscoe Municipal Officers Electoral Board meeting to order at 5:30 PM on Tuesday, December 20, 2016.

**2) ROLL CALL**

Chairman Krienke called for Roll: Present: President Krienke, Trustee Baxter, Clerk Marks

**3) APPROVAL OF MINUTES**
