5. PRESIDENT'S REPORT - Dave Krienke

Approval of Resolution 2017-R11, a Resolution authorizing Addendum #1 to the Architectural Services Agreement dated December 17, 2015, between the Village and Kluber, Inc. for Police Station Design Services, to add, as additional services, construction document updates and revisions for an amount NTE \$39,870.00. President Krienke entertained a motion to approve. Trustee Gustafson made a motion to waive the 1st reading and make it a final reading; seconded by Trustee Muradian. Roll Call Vote: Trustees Gustafson, Mallicoat, Muradian, Swanson Yes. Trustees Baxter, Petty No. Motion to waive 1st reading approved 4-2-0. President Krienke called for a motion to approve the final reading. Trustee Gustafson made the motion; seconded by Trustee Muradian. Trustees Baxter, Petty, Swanson No. President Krienke broke the tie Yes. Motion approved 4-3-0.

Approval of Resolution 2017-R13, a Resolution of the Village of Roscoe authorizing the Village to enter into a Professional Services Agreement with Nicolosi Galluzzo, LLP, to serve as special counsel for the financing of the Village Police Department addition NTE \$15,000.00. President Krienke stated the agreement was a draft and Attorney Kurlinkus would like to make some changes to it before signing. It is required by Federal law that Municipalities have a financial advisor for the process. President Krienke entertained a

motion to approve. Trustee Gustafson made a motion to waive the 1st reading and make it a final reading; seconded by Trustee Mallicoat. Roll Call Vote: Trustees Gustafson, Mallicoat, Muradian – Yes. Trustees Baxter, Petty, Swanson – No. President Krienke broke the tie – Yes. Motion to waive 1st reading approved 4-3-0. President Krienke called for a motion to approve the final reading. Trustee Gustafson made the motion; seconded by Trustee Mallicoat. Roll Call Vote: Trustees Gustafson, Mallicoat, Muradian – Yes. Trustees Baxter, Petty, Swanson – No. President Krienke broke the tie – Yes. Motion approved 4-3-0.

President Krienke entertained a motion to approve the consent agenda from 7.1 through 7.4 as amended. Trustee Gustafson made the motion; seconded by Trustee Mallicoat. Roll Call Vote: Trustees Gustafson, Mallicoat, Petty, Swanson - Yes. Trustee Baxter - No. Trustee Muradian - Abstain. Motion approved 4-1-1.
