7.1 President Krienke entertained a motion to approve the Consent Agenda which includes the April 3, 2018 Village Board meeting minutes and Resolution 2018-R17, approval of Bid specifications and bid letting for emergency tree trimming and tree removal services Trustee Petty made the motion, seconded by Trustee Szula. Roll Call Vote: Trustees Baxter, Petty, Gustafson, and Szula – Yes.

- **8.1 Approval of Resolution 2018-R14,** authorizing the purchase of a new server and related software for the Roscoe Police Department (NTE \$7,700.00). Trustee Baxter questioned as to whether or not it would be beneficial for Village hall and the Police Department to share a server. President Krienke stated that one server would not be big enough for both. Chief Evans pointed out that it would not be feasible due to privacy issues, especially regarding juveniles. Roll Call Vote: Trustees Petty, Gustafson, Baxter and Szula Yes. **Motion Passed** 4-0-2
- **8.2** Approval of Resolution 2018-R17, a resolution declaring surplus and authorizing it's sale at public auction, two Roscoe Police Department squad cars. Trustee Szula made a motion to approve, Trustee Petty seconded the motion. Roll Call Vote: Trustees Szula, Baxter, Gustafson and Petty Yes. **Motion Passed** 4-0-2
- **8.3 Approval of Resolution 208-R16** approving the final plat of the Plat of Main Street Square (creating two separate lots at Main Street Square, 534 Williams Drive). Administrator Sanders commented that this in an effort to satisfy requirements needed to create an extra 200 feet of separation between Ryan Brewing Company and the school. Trustee Baxter made a motion to approve, seconded by Trustee Petty. Roll Call Vote: Trustees Szula, Baxter, Gustafson and Petty Yes Motion Passed 4-0-2
- **8.4** Approval of Village Street closures for the Memorial Day Parade occurring on May 28, 2018. Trustee Sula made a motion to approve, seconded by Trustee Petty. Roll Call Vote: Trustees Sula, Petty, Gustafson and Baxter Yes Motion Passed 4-0-2
- **8.5** Approval of jointly letting for bid the 2018-2019 Snow Season Salt Contract with Winnebago County, Illinois. President Krienke noted that the approval is for bid only and not cost of salt.
