

**VILLAGE OF ROSCOE
ORDINANCE NO. 2018-09**

**AN ORDINANCE ESTABLISHING THE PREVAILING RATE OF WAGES FOR
LABORERS, WORKERS, AND MECHANICS EMPLOYED ON PUBLIC
WORKS OF THE VILLAGE OF ROSCOE**

WHEREAS, the State of Illinois has enacted “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the state, county, city or any public body or any political subdivision or by any one under contract for public works,” approved June 26, 1941, as amended (820 ILCS 130/1, *et seq.*; and

WHEREAS, the aforesaid Act requires that the Board of Trustees of the Village of Roscoe investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Village of Roscoe employed in performing construction of public works for said Village of Roscoe.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSCOE, ILLINOIS, AS FOLLOWS:

SECTION 1: To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in construction of public works coming under the jurisdiction of the Village of Roscoe is hereby ascertained to be the same as the prevailing rate of wages for construction work in Winnebago County as determined by the Department of Labor of the State of Illinois as of June 2018, a copy of that determination being attached hereto as Exhibit “A”, and incorporated herein by reference, and any subsequent amendments thereto. The definition of any terms appearing in this Ordinance that are also used in that Act shall be the same as in that Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village of Roscoe to the extent required by the aforesaid Act.

SECTION 3: The Village of Roscoe Clerk shall publicly post or keep available for inspection by any interested party in the main office of the Village of Roscoe this determination or any revisions of such a prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications for any public works project of the Village of Roscoe.

SECTION 4: The Village of Roscoe Clerk shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Village of Roscoe Clerk shall promptly file a certified copy of this Ordinance with both the Illinois Secretary of State and the Illinois Department of Labor, or as otherwise shall be required.

SECTION 6: The Village of Roscoe Clerk shall cause to be published in a newspaper of general circulation within the area, notice of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of the Village of Roscoe.
