Administrator Sanders commented that the event is this Saturday from 3:00PM-8:00PM. There will be a live jazz band at Village Hall from 4:00-7:00; the community tree lighting will be at 6:00PM, and there will be other activities around town as well. Roll Call Vote: Trustees Baxter, Mallicoat, Szula, Gustafson, Swanson and Petty Yes. **Motion Passed 6-0-0**
- **8.10** Approval of Ordinance 2018-23, establishing a \$500 Application Fee for New Liquor License Applications. Trustee Szula made a motion to approve; seconded by Trustee Gustafson. Roll Call Vote: Trustees Gustafson, Petty, Swanson, Baxter, Mallicoat and Szula Yes. **Motion Passed 6-0-0**
- 8.11 Approval of Ordinance 2018-24, increasing the annual license fee for the Class "BL" (Boutique Gaming) liquor licenses to \$6,000.00 per year, effective for Class "BL" licenses issued after January 1, 2019. Trustee Swanson made a motion to approve; seconded by Trustee Petty. Trustee Baxter requested more information

regarding the increase in the license fee. President Krienke responded, and stated that the amount was a recommendation from the Liquor Commission Board. Trustee Gustafson commented that the state only allows the Village to charge \$25 per machine in any of these establishments. Compared to the substantial amount of money these businesses bring in the extra \$1000.00 is minimal and would help with a multitude of expenses in the Village. Roll call Vote: Trustees Gustafson, Szula, Baxter, Swanson, Petty and Mallicoat – Yes, **Motion Passed 6-0-0**

8.12 Approval of Ordinance 2018-25, establishing revenue based eligibility requirements for holders of Class "A", Class "C", Class "D", Class "G" and Class "F" liquor licenses in the Village of Roscoe. Trustee Swanson made a motion to approve; seconded by trustee Szula. Administrator Sanders explained that this is creating an 'either-or' condition based upon the percentage of revenue a business makes from gaming. If the revenue is greater than 51% the business has to be considered a class "BL". If the revenue from gaming is less than 50% they would fall into one of the other Classes. There will be an affidavit of compliance signed at the time of license issuance. The village has the ability to verify the amount quarterly. This will go into effect for renewals in 2020. Roll Call Vote: Trustees Szula, Petty, Gustafson, Mallicoat, Baxter and Swanson – Yes. **Motion passed 6-0-0**
