

2023 TOTAL COMPENSATION PACKAGE

Pursuant to ILCS 120/7.3 any IMRF employer has a duty to post the following information for any employee having a total compensation package that exceeds \$75,000 per year. Total compensation for the above purpose includes salary, health insurance, a housing allowance, a vehicle allowance, a clothing allowance, bonuses, loans, vacation days granted and sick days granted.

Pursuant to Village of Roscoe Resolution 2016-R40, the Village of Roscoe shall post total compensation for all full time employees, elected officials, part time employees and appointees. Total compensation for the above purpose includes salary, health insurance, a housing allowance, a vehicle allowance, a clothing allowance, bonuses, loans, vacation days granted and sick days granted.
