3. APPROVAL OF MINUTES

3.1 Approval of July 20, 2021 COTW minutes.

5. NEW BUSINESS

5.1 Discussion and **recommendation to the Board for approval** of a Memorandum of Understanding between the Winnebago County Health Department and the Roscoe Police Department implementing a drug overdose prevention program.

Discussion: Administrator Sanders summarized the recommendation stating that this agreement was with the Winnebago County Health Department and the Roscoe Police Department to implement the drug overdose prevention program which is funded through the Illinois Department of Human Services. Funding has been received from the Illinois Department of Human Services, Division of Substance Use

Prevention and Recovery, to purchase Naloxone (NARCAN) kits, train local community residents, businesses, faith communities, not-for-profit staff, and local emergency responders to administer Naloxone (NARCAN) to individuals suspected of having overdosed on opioids;

5.5 Discussion regarding continued landscape maintenance/improvements of boulevard islands within the public right-of-way at entrances to the Crystal Hills, Clearwing, and Prairie Ridge Subdivisions.

Discussion: ***Due to technical difficulties hearing during this portion of the meeting as well as the recording technical difficulty I Stephanie Johnston Village Clerk of Roscoe was not able to capture the full discussion. Administrator Sanders summarized the conditions of the islands, stating they are dead and full of weeds. It was stated that it was already cleaned up, and that it is not a good time to plant however something to prepare for. Administrator Sanders stated it would cost an estimate of about \$3000 - \$4000 per island.

Many of the signs are missing, old rotted and many of the subdivisions do not have signage. Administrator stated he has been traveling throughout the Village and taking pictures, documenting conditions and any issues.
