**5.3.** Discussion regarding establishment of a local grant program to mitigate pandemic related adverse economic impacts on businesses located within the Village of Roscoe.

Administrator Sanders summarized the discussion, stating this was from discussion to use proceeds of the American Rescue Plan to establish a grant program in the Village of Roscoe from Trustee Gustafson. Trustee Gustafson summarized her idea that her intentions are not to take the entire 1.4 million from the American Rescue Plan but wanted to look at the 50% reduction in liquor license revenue which is roughly \$42,300 verified by Administrator Sanders. Trustee Gustafson stated taking maybe \$100k, the idea is to help those establishments that suffered economic loss but didn't pour alcohol. Stating that maybe those establishments who did pour alcohol who received the reduction in fees, but still the economic loss is greater than the reduction in fees could apply as well. Trustee Gustafson stated that this idea was to help those business and establish by developing a grant program. This would be overseen by a grant administrator, and if business applied great if not then the money could be moved to the general fund. Administrator Sanders inquired how would the grant money be distributed, what amounts. Trustee Gustafson stated the Village could set the amount based on the level of need, and the impact demonstrated like a range of \$2k to \$5k, which is a small amount like the liquor license reduction. Administrator Sanders stated that there have been Roscoe local businesses that did receive government assistance the PPE plan \$25 million for payroll catch up. Trustee Petty asked Administrator Sanders to please explain the plan, which he stated the payroll protection plan (PPP) was a grant program that had to be applied through by banks, that was applied for assistance. Administrator Sanders stated if the business met the criteria the loans were forgivable. Trustee Gustafson stated that some businesses did not meet or qualify so that is why she requested to establish the program.

**5.4.** Discussion and recommendation to the Board of the 2022 Village of Roscoe Annual Budget in tentative form

Administrator Sanders summarized the second draft of budget, going over what was updated and changed. The overall change is roughly \$36,000 which was over committed and the changed tonight of the reduction in revenues from the reduction fees from the liquor licenses. Administrator Sanders stated he pointed out anything that was new, and one minimal change is with the Police Department in creating a new position of Administrative Sargent.
