**5.1.** Discussion and Recommendation of entering into an agreement with ClearGov, Inc. for municipal budgeting software, including operational, capital, and personnel budgeting, and transparency portal.

Administrator Sanders provided a summary of the recommendation for ClearGov. ClearGov transparency portal is a link at the bottom of website allowing the public to see all the revenue and expenditures. Currently the Village is only subscribed for that portion of the transparency portal. ClearGov has a robost software package that helps with budgeting process. Attorney Kurlinkas stated that this company is used in 49 states, and

assists with Operational, Capital budgeting. This will allow import data, and is user friendly with easy access. The first year cost is \$16,053 with subscription around \$13,713.

Trustee Mallicoat asked if the board would see benefits this year? Administrator Sanders stated yes the Trustees would see improved information.
