**MINUTES of OCTOBER 06, 2021 SEMI-MONTHLY MEETING of THE  
VILLAGE OF ROSCOE BOARD of FIRE AND POLICE COMMISSIONERS**

The October 06, 2021 Semi-Monthly Meeting of the Village of Roscoe Board of Fire and Police Commissioners convened at 6:30 p.m. at the Roscoe Village Hall. Chairman LeAnn Jones and Commissioner Mark Nytko were present. Deputy Chief Sam Hawley, Attorney Charles Kostantacos and Secretary Victoria Eggers were also present. Commissioner David Jacobson was unable to attend.

The Meeting was called to order at 6:34 p.m. by Chairman LeAnn Jones. The roll was called for the record: Chairman LeAnn Jones and Commissioner Mark Nytko were present. There was a quorum.

**MINUTES**

The Minutes from the Regular Meeting of September 01, 2021 were reviewed and discussed. Being as there were no suggested corrections, the Minutes were approved as drafted and distributed on motion by Commissioner Nytko, seconded by Chairman Jones and followed by a unanimous vote.

**CLOSED SESSION**

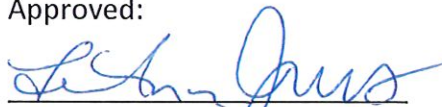
