3.1 Hearing on Possible Revocation, Suspension, or Other Penalties

Licensee: JIM SHELL LLC d/b/a Jimez Sports Bar & Grill
License: Class 'F' Liquor License / License No. 455-22
Docket #: 2022-LCC-01

President Szula read item 3.1 and referred to Attorney Kurlinkas to summarize, Attorney Kurlinkas stated that on February 21, 2022 at approximately 10:00pm that Jimez employee Steven Price was serving alcohol to someone under the age of 21. The Roscoe Police were called out and it was investigated and confirmed. Price did not have a certificate of registration, which is required by the Village of Roscoe Code of Ordinance 114.04.

Attorney Kurlinkas went on to state that the establishment Jimez has been fully cooperative and the employee was terminated. It has been recommend that Jimez be fined \$1500, to be paid no later than April 8, 2022. The Village of Roscoe has suspended Jimez’s license to sell alcoholic beverages pursuant to Village of Roscoe Code of Ordinance for one (1) business day during the month of April.
