Discussion: Stateline Chamber has a request to carry on a Beer Fest for October 22, 2023. The details are still being worked out, and they have the vendors lined up. Once this is completed the official permit will come to the board. Trustee Sima inquired how many Beer Vendors would be and are they considered under an umbrella license? President Gustafson stated yes, it would fall under RJR Gaming and responsible party. They would be working as the distributor. President Gustafson stated it would

be the prerogative of the board to set the number of beer tickets to purchase. Currently there is no knowledge of the number of vendors, and Administrator Sanders stated they would be meeting with Stateline on Monday October 25, 2023 and should know then.
