8.0 MOTIONS AND RESOLUTIONS (FINAL ACTION)

8.1 Authorization for Village President to enter into an agreement for renewal of natural gas supplier contract, recommended 3 year term. Trustee Petty made a motion to approve, seconded by Trustee Swanson. Administrator Sanders explained that much like Electric Aggregation, delivery and supply are separate. Delivery is a fixed amount, thus remains the same. The Village as a municipality has the authority to change

the supplier. There are three different suppliers to choose from, all with slightly different rates per therm. Currently Nicor Gas is at .36 cents. Constellation Energy is at .333 cents. The lowest bid came from Santana Energy at .32 cents a therm. Choosing Santana would result in a \$159 per year savings. Roll Call Vote: Trustees Gustafson, Petty, Swanson, Baxter and Mallicoat – Yes. Motion Passed 5-0-1

9.1Authorization for purchase of various Information Technology components, including hardware and software for Village Hall, Public Works, and Police Department for quoted amount of \$12,920.56 Trustee Gustafson made a motion to Suspend Rules and make this a final reading. Trustee Mallicoat seconded the motion. Roll Call Vote: Trustees Petty, Swanson, Mallicoat and Gustafson - Yes. Trustee Baxter - No. Motion Passed 4-1-1 President Krienke entertained a motion to approve the original motion as amended and make this a final reading. Trustee Gustafson made the motion; seconded by Trustee Mallicoat. Roll Call Vote: Trustees petty, Gustafson, Swanson and Mallicoat – Yes. Trustee Baxter – No. Motion Passed 4-0-2

Administrator Sanders provided a quick analysis of video gaming revenue for the month of January. The NTI (Net Terminal Income) for the 89 machines located in the Village of Roscoe was \$509,728.00 in January, down slightly from 2018 but significantly higher than 2017. It projects out to an annual terminal income of \$7.28 million, with the Village's percentage being \$364,000.00.

Administrator Sanders provided an update on Denali Heights. He stated that the Petry's attorney appeared at the last ZBA meeting requesting a layover. The attorney stated that the Petry representatives were planning on being at tonight's 03-05-2019 Village Board Meeting. They did not appear.
