# 4. PUBLIC COMMENT (Limited to 3 minutes per speaker)

President Szula addressed the public if they are wishing to address the board regarding the annexation agreement with Seed Real Estate LLC for parcel located at 13276 White School Road that should be addressed in the Committee of the Whole Meeting. Administrator Sanders pointed out to the public that the meeting follows the Village Board Meeting and their concerns would be heard and addressed in that meeting.

**8.3.** Approval of modifications to the Pandemic Emergency Staffing Plan (adopted March 19, 2020) President Szula entertained a **motion**,

\*\*Administrator Sanders pointed out to President Szula that new language has been added to the Pandemic Emergency Staffing Plan in reference to the off site training and events. Stating that no Village Employee is permitted to attend in person or off site training unless they have been fully vaccinated.

Trustee Gustafson made a motion to layover until next meeting for several reasons;

Trustee Gustafson motioned to move to next meeting based on the following:

- The language in the document has conflicting directives to staff that can be confusing. For example one section states "individuals do not have to wear masks if in company of someone who has been vaccinated" but later in the language it states employees has to wear masks and can not occupy the same vehicle
- A second conflict in regards to the CDC guidelines in cleaning.

Trustee Gustafson, moved to hold this off to next meeting so that document can be gone through and see what corresponds to the latest directives. And not hold people to such ridgid practices and have the language cleaned up.

**8.4.** Approval of **Resolution 2021-R18**, authorizing the hiring of additional part-time police officers, and establishing a starting wage of \$24.50/hour.

Discussion: Administrator Sanders summarized that the suggested rate is listed as \$24.50 on agenda, but in Committee of the Whole it was \$22.50. The decision was based on the most current data and the competitive nature of trying to seek out full or part time officers. Chief Evans stated from the last meeting it was made aware that another agency had raised their hourly rate. Chief stated that we are competing with everyone right now and she is trying to attract part time officers. It was realized that the rate of \$22.50 was not competitive enough based on the current conditions.

President Szula entertained a motion,

Trustee Petty made a motion to approve;

Seconded by Trustee Plock

Discussion: Trustee Dunn inquired if this meets all the criteria for certified officers and lateral moves that the police commission sets forth? Chief Evans stated yes, that they could test now and get on current list or test later and get on the lateral list.

**8.5.** Approval of **Resolution 2021-R19**, authorizing entering into an agreement with Stenstrom for completion of the 2021 Class D pavement patching program for the budgeted amount of \$100,000.00.

# 9. NEW BUSINESS (FIRST READING or SUSPEND RULES)

**9.1.** Approval of **Resolution 2021-R20**, authorizing the Village President to solicit bids, negotiate, and enter into a wholesale electricity supply contract not to exceed three years in length for the Village of Roscoe Electrical Aggregation Program.

Discussion: Administrator Sanders summarized that the scheduled laid out has changed, that the numbers and rates were tracked and feel it is an attractive time to solicit the bids. It was agreed that it would benefit all three municipalities (Roscoe, Loves Park and Rockford) to do the bid in the month of April. All three municipalities are taking action, and the final bid will be in the coming weeks. Formal ratification for resolution will take place in the second meeting of April for all three municipalities.

Discussion: Trustee Gustafson asked if Administrator Sanders could review what offering civic grant and information in table adds to the bid? It is a civic kick back, a donation to the municipality for using them as service provider.

Trustee Plock addressed the board that he secured 600 ton of aggregate for the parks.

Trustee Gustafson inquired about the warranty on the residential street program. She is referring to her subdivision when the streets were repaired. She stated that the roads are crumbling quickly and it has only been 2 years. It is cracking and crumbling in the center of the road. President Szula offered to drive out along with Brandon and Wade to come out and take a look. Administrator Sanders stated this should not be centerline cracking and they would look into it.
