  - 5.1. R1 Regional Planning/NorthCOG Presentation Michael Dunn Jr. President Szula introduced Michael Dunn Jr; Mr. Dunn Jr introduced himself as well as summarized why he was attending the meeting. Mr. Dunn stated Region 1 Planning Council (RPC) is special-purpose, regional government agency. Regional councils are public organizations comprised of local elected officials that promote collaboration among local governments, working across the jurisdictional silos of states, counties, and municipalities. Mr. Dunn summarized the services as well as the "Landbank Program". Mr. Dunn advised members as Boone County, City of Belvidere, City of Freeport, City of Loves Park, City of Rockford, City of South Beloit, McHenry County, Village of Machesney Park, and Winnebago County. President Szula brought up that he was premature on his comment about adjusting the liquor license fees back to normal cost. ### 9. NEW BUSINESS (FIRST READING or SUSPEND RULES)

No New Business, President Szula wanted to have a conversation about how it went on Halloween. President Szula stated many of the surrounding communities are considering jumping on board to moving to the last Saturday of the month. Trustee Keene stated the purpose of Halloween was to create a family friend event, which this community stands for. Trustee Keene feels it was a successful weekend having it on Saturday, and he gave out over 270 pieces of candy. Trustee Keene stated this is a learning curve, and that the board will need to re-evaluate how to transition people through the sub-divisions. Trustee Keene and Trustee Plock discussed having a oneway traffic pattern, and work something out to be able to have foot traffic as well as traffic through the sub-divisions. Trustee Keene also stated that holidays throughout the year some are static, Memorial Day, Labor Day Thanksgiving are static. Trustee Keene it benefits the kids so they can have a good time. President Szula stated the Chicory Ridge sub-division takes Halloween seriously, and that the thru traffic needs to be able to get to their destination. President Szula suggested next year maybe having people park at Chicory Ridge Park and stated that the Village can make it better and safer.

Trustee Dunn stated 4th July and Christmas are static holidays, and Halloween was up until the board changed it. Trustee Keene stated that Memorial always falls on a Monday, and the date changes. President Szula stated we changed it for "public safety", Trustee Dunn wanted to know what Trustee Keene did for the other hour and forty-five minutes when he ran out of candy. Trustee Keene stated he took his wife to dinner. Trustee Gustafson wanted to know prior to changing the date did Chicory have the traffic nightmares? Trustee Keene and President Szula stated "oh yeah", President Szula stated it was the first time he met people from the back of the subdivision. Trustee Gustafson wanted to know how many communities were considering moving, President Szula stated S Beloit, Machesney Park and Loves Park. President Szula stated for public safety reasons it makes sense to move it. Trustee Gustafson stated the board should still honor those of Chicory Ridge who sent the board emails and pictures who wanted answers as why the board changed the date and what the board will do differently. Trustee Gustafson stated their points were valid, President Szula stated that the points are valid and that the board needs to improve on it. Trustee Keene stated there was very little feedback regarding moving the date, Trustee Keene stated this is a change that takes people out of their traditional comfort zone. Overall, there was mixed reviews of moving the date from the community per Administrator Sanders and the board is taking action to improve it for next year.
