**8.1.** Approval of **Resolution 2021-R47**, authorizing the acquisition of a 2022 Chevy Silverado 1500 LT under the terms of the Village's Master Lease Agreement with Enterprise Fleet Management Inc., for use by the Village Administrator, for the quoted price of \$35,246.00

**8.2.** Approval of **Resolution 2021-R48**, authorizing the filing of requests to intervene in the 2021 property tax assessment complaints before the Winnebago County Board of Review for properties requesting reductions exceeding \$100.000.

President Szula called on Attorney Kurlinkas to summarize, Attorney Kurlinkas stated that this if they are asking for a reduction of over \$100,000 then the Village is allowed to intervene and work with the Winnebago County assessor's office, stating that this needs to be

filed within 3 days so as soon as the notice is received it will be put on the agenda right away. Once he speaks with accessors office then he will bring to the board. So basically, the Village is filing a notice to intervene. Trustee Gustafson inquired what the success rate is, with Attorney Kurlinkas responding that generally the accessors office agrees, but there are times that they will state that the rate is valid. Trustee Gustafson inquired to the timeline when this would be decided, Attorney Kurlinkas stated generally February.

**9.1.** Approval of **Resolution 2021-R49**, authorizing a temporary 50% reduction in liquor license renewal fees for the year 2022 for existing license holders in the following categories: Class A, Class BL, Class BP, Class D, and Class F.

Discussion: Trustee Dunn inquired to the figures/ data and what the numbers where that were requested in last meeting, just how far behind these business are. President Szula stated that the businesses did not go into full operation until June. Trustee Dunn stated that there should still be some data/numbers to back up this request. Trustee Dunn stated he is thinking of the boards responsibility that to just vote to reduce fees by 50% is not doing our duties as elected officials. President Szula stated he has spoken to an awfully a lot of people and their numbers are down by 30 to 40%, which Trustee Dunn stated but we are reducing by 50%, therefore there should be some kind of data to back up this request.
