Steve summarized the YTD Report, stating that general fund revenues were \$7,033,000 and expenditures were \$5,878,000 resulting of an increase into the fund balance of \$1,155,500. Expenditures were close to budget and salaries and benefits came in at  $1\frac{1}{2}$ % under budget. Covid expenditures came in at 2% under budget, revenues were underestimated from original budget, revenues were \$1.6 million over budget.
