**9.1.** Approval of **Resolution 2022-31**, authorizing a three-year extension of the municipal auditing services agreement with Baker-Tilly for a total amount not to exceed **\$68,645.00** (avg \$22,881.66 per year)

President Szula called on Administrator Sanders to give slight overview on the products and costs. Initial contract is 3 years for average \$22,881.66 which is an increase of \$2300 oer year when taking in 3-year block. Administrator Sanders stated he spoke to Mark Olson and Steve regarding their opinion, and they feel that Baker Tilly is doing an excellent job

as well as easy to work with. Trustee Gustafson mentioned that she had attended a conference and remembered that municipalities should change their auditors periodically and suggested that regardless of rates going up we should look at competitive bids. President Szula acknowledged that is good business practice. Administrator Sanders stated that the Village is seeing smaller numbers in the bids.
