9.2. Discussion and Recommendation regarding solicitation of competitive bids for Collection of Residential Refuse, Recycling, Bulk Waste, Yard Waste, and for billing services associated with same.

President Szula stated that we have to be good stewards of the tax payer's money and put this out to bid.

Discussion about garbage:

Trustee Gustafson would like that the Village Identify a cafeteria type program and homeowner pick and choose the types of services they want. For example, yard waste, recycling. Trustee Gustafson would like separate fee for yard waste items, bulk item as well as the billing. As well as the size, etc. Gustafson would like to give the residents a chance to opt out or control what they spend.

Administrator Sanders stated he agreed about the ala-cart but it would likely drive prices up. It's not unusual to see yard-waste and bulk collection and done at additional cost. Recycle optional may just make people put things in the garbage.

Trustee Gustafson asked about the length of contract?

Administrator Sanders stated maybe three years with some sort of annual adjustment. Administrator Sanders stated the Village can dictate the terms and requests, we do allow discretionary opt-out, but should caution this.

Trustee Dunn ask if the various options would cause issue and raise price since the Village doesn't do the billing.

Trustee Gustafson inquired about time frame, President Szula said rather quickly, Administrator Sanders stated he would like someone to request special meeting for approval.

Attorney Kurlinkas stated we need recommendations from the board for what they want, Tote Size, Every other week recycling, yard waste?

Toter Size:

96 gallon a standard, but if resident request a 35 gallon then company be obligated to provide. Trustee Gustafson stated yard waste is not something needed. Make that as an additional cost. Administrator Sanders stated bulk items should be additional. Administrator Sanders stated that he knows the price is going up, the Village had an outstanding fantastic contract. Trustee Gustafson stated Christmas Tree Collection could be dropped. President Szula asked if everyone is good with 630pm meeting next Tuesday September 27, 2022.

10. OLD BUSINESS

Brandon gave capital project report:

- No major update on Mainstreet, except for design of pedestrian bridge.
- Willowbrook Road. IDOT was checking the traffic analysis. Waiting for IDOT review team. Need TIA before IES.
- Love Road: we received additional IDOT comments, we now have additional tollway comments.
- Shephard Hills: we are awarding and then meeting with contractor.
- Public Works parking lot project. Contractor has contracts
- MFT/Frontage: Received contracts back. We will have this back next week.
- Residential Streets: this was completed a few months ago. Waiting for contractor to review quantities and measurements. Pay application to contract.
- Porter Park. Paved and striped.
- Public works building addition. The building is up. There was a break in the schedule waiting for insulation. Hope to pour slab 4 in a week or two.

Trustee Gustafson stated porter park parking lot looks good. The porter park cabin has lack of maintenance. We spent 22000 on lighting, but porter park cabin needs maintenance, mushrooms growing, ac is bad, the cabin is not being maintained. Carol would like to get an estimate to maintain the building, and keep what we have. We need to power wash, and stain the logs. We have ignored too long. President Szula stated that we can get someone out there and get it worked on.

Trustee Gustafson would like to have staff present at the board meetings as well as have staff here in person. Trustee Gustafson stated voluntary is fine.

President Szula stated that we have made it voluntary, but they can come back in person.
