6.3. Final 2022 YTD Report Revenues and Expenses

President Szula called on Steve regarding the 2022 YTD, Steve stated that General Fund Revenues finished the year at \$8.2 million, which is \$2 million more than budgeted, Expenditures finished the year at \$7.5 million which is about \$200k under budget, original budget had deficit balance of \$1.5 million however ended year with surplus of over \$700,000. The General Fund Balance was \$6,374,000.00 up from \$5,674.000 previous year. The drivers of the surplus were \$435,000 from the Cares Grant from first stimulus, which was received in 2022. Revenues were strong and sales tax and use tax flattened out, income tax was higher. A Budget transfer is recommended for certain line items and this will be presented to board during first meeting in March.
