4. PUBLIC COMMENT (Limited to 3 minutes per speaker)

Janette Ronke, has concerns on road construction on road, Sprague Rd, turns into Liddle Road. Janette stated it is dangerous going west on Roscoe Road to turn on Sprague Rd. The road is narrow and deteriorating, and used as a "cut through" to get to the middle school and Old River Road. Brandon stated it is a road that has dual jurisdiction, from Rockton Township, Rockton Village, Roscoe Village and Winnebago County. Brandon stated that WinGis doesn't reflect it, but he believes it is Roscoe's Road as Roscoe is maintaining it.- Administrator Sanders presented the jurisdictions with the boundaries stated that they would look into where the jurisdiction lies and who is responsible for the roads.

5.1. Informational Presentation by Clarke Environmental Mosquito Management

Administrator Sanders introduced Jack Thennisch of Clarke Environmental Mosquito Management. Mr. Thennisch gave an overview of the company stating Clarke is a thirdgeneration family-owned company since 1946. Administrator Sanders referred to Brandon, the residents wanted to know why the construction stopped at Applegate, why it wasn't done through to Belvedere Road. Administrator Sanders presented the board with the visual of the roads, pointing out the jurisdiction of the road.

Trustee Plock would like to consider looking at getting the designs plans started for the roads for next year and bike path. Trustee Plock asked for a ball park figure for the bike path. Administrator Sanders stated he will share with everyone when he has it.
