10. OLD BUSINESS

Brandon Boggs- Village Engineer provided update regarding Main Street. Mr. Boggs spent some time with ComEd in reference to the electrical configuration. Mr. Boggs stated it's a large cost, major issue is figuring out the cost sharing with ComEd, and if relocated underground who is responsible. Currently there is an estimate from their engineer design team. Next steps are meeting with ComEd engineering design team, working out several issues as well as the construction timeline. This may take 4-6 months, and currently no funding although going after grant funding. Administrator Sanders stated there are several variables to work through on this.

Chief Hawley provided an update on the hiring process, stating there was a test on Saturday with 61 people of interests, and 31 completed applications. Chief Hawley stated that 15 showed up for written test, with only 7 passing. He is currently looking at November 1st finalist will be

listed, then conditional offers, with psychic tests and academy.

Troy, provided update on the Porter Park Cabin, stating the company went beyond and the Cabin looks beautiful. They fixed a lot of drafts, and the wooden ramp has been replaced. Ceiling fans and new vents have been installed; everything is looking really nice.

President Gustafson thanked Janel for all her assistance with coordination of schedule and events.

Trustee Plock inquired if anyone would be interested in keeping the October 24th meeting on Tuesday to discuss Parks and facilities since we are coming up onto budget times. Trustee Wright stated that would be a lot of Tuesdays for this month of October. Trustee Petty wanted to know what the goal is. Trustee Plock stated it was to get a discussion going and a plan for budget time there are more parks not just Porter Park and Leland. Trustee Sima stated it is a great idea, but for rules of order and consistency and determine dates. Trustee Sima suggested getting a schedule for topics and discussed in advance, however, make it consistent. Trustee Plock stated technically there was supposed to be a meeting on the 10th now being moved to the 24th. Trustee Mallicoat stated he would like to see it done on the 10th, that this time of year we will be busier due to budget. Trustee Gustafson inquired who would be available on the 10th? Trustee Mallicoat, Sima, Petty, Plock, Wright, Babcock are all available. This will now be discussed on the 10th. This will be posted to public.
