Chief Hawley recognized and presented awards to Officer Anna Podgorny, Officer Greg Yalden and SGT Robert Lewis. Chief Hawley provided the board with an overview of the incident involving officers responding to a fire at a two-story family residence on November 12th. The incident involved officers trying to force entry into the apartment by kicking and using a 2-by-4 as RAM, but with no success. Sergeant Lewis entered the smoke-filled stairway and rescued two children from the back bedroom, picking up one child in a crib. Fire Chief Bergeron presented all three with awards recognizing and thanking the officers for their efforts.

9. NEW BUSINESS (FIRST READING or SUSPEND RULES)

9.1. Approval of Ordinance 2023-18, approval of amendments to Chapter 22, Article I, Sec. 2-121 of the Village of Roscoe Code of Ordinances related to position of Village Administrator.

First Reading only:

Trustee Mallicoat stated he has given a few notes for Attorney Kurlinkas to review Trustee Petty, stated she would like everything referred to Village President and Board of Trustees to clean up the language and make it uniformed. Attorney Kurlinkas stated sure he can clean that up. Trustee Petty also inquired about the term removal and selection process, Attorney Kurlinkas stated its an appointed position. Trustee Petty requested that the wording be changed and Attorney Kurlinkas stated that it's the boards ordinance you can do that.

Trustee Plock stated he would prefer it be 4 Trustees in favor not a tie breaker vote. Currently it is 4 Trustees and with an appointed position the Village Board votes the President does not vote. Trustee Mallicoat inquired if the Village Administrators answers to the board, and Attorney Kurlinkas stated yes and read off the section of the ordinance. Trustee Plock stated he understands the rush, but this should have gone to Committee instead of Board.

9.2. Approval of Resolution 2023-R61, a resolution approving an employment agreement with Josef Kurlinkus to serve in the position of Village Administrator.

First Reading Only:

Trustee Mallicoat stated he has spoken to Attorney Kurlinkas regarding the clean up of the language. Trustee Mallicoat stated this should have also went to Committee first so that the board could review. Trustee Mallicoat questioned the clause where it stated that the board can only go thru administrator before any employees. Attorney Kurlinkas stated this was set in the past to set boundaries. Trustee Mallicoat stated it needs to be cleaned up and if any board members have issues or questions with the resolution to reach out to Attorney Kurlinkas.

In summary:

The role of the village administrator was discussed, with the president and board of trustees to appoint and oversee the administrator. The president's role in the decision-making process was clarified, with emphasis on presenting matters to the board for their decision. The need for at least four trustee votes in favor of a decision was highlighted. The administrator's reporting line was a point of contention, with a consensus leaning towards reporting to the board. The meeting also discussed the scope of Village's responsibilities and potential conflicts of interest. The need for a village attorney was clarified, with some legal matters that could be handled inhouse and others requiring an outside attorney. The importance of transparency and comprehensive discussion was stressed throughout the meeting.
